2010 ANNUAL REPORT OF THE EXECUTIVE MINISTER

Dr. Liliana Da Valle, Executive Minister

2010 was a very difficult year in the life of the American Baptist Churches of Rhode Island (ABCORI). It was a year characterized by losses. Among other brothers and sisters who went to be in the presence of the Lord, we lost our beloved Hank Pedersen, a great leader among us, and his dear wife Fran moved to Minnesota. Both left a big empty spot in our organization.

In the summer we lost staff in key positions, which created both a great fallout and the need to restructure our staff configuration. Summer camp suffered the loss of its director and much distress fell over ABCORI. It was a time when the family needed to pull together and most of us did. As your executive minister, I have appreciated the level of trust placed on me and my leadership at the time.

Since the summer my workload increased tremendously as I tried to take care of camp, finances, a host of other responsibilities, and dealing with the fallout while continuing my regular ministry. Due to legal reasons, I was prevented from sharing information about the terminations, which made some people uneasy. The silver lining in all this was the love and support of a host of loyal brothers and sisters who held up my arms, and the amazing response of the staff at Canonicus, who rejoiced in the change of leadership style.

At the beginning of December, when I announced my resignation from the position of Executive Minister, ABCORI suffered yet another loss. As I have stated publicly, I am leaving because I truly believe my job is done. I also believe that ABCORI needs a different kind of executive, one with the knowledge and experience to help figure out how to face the future in terms of organizational structure and finances.

Let me be clear, we have a new structure for ministry that is working well; when I talk about organizational structure I refer to reconfiguring staff patterns to cover all the bases. In these difficult economic times, much skill is needed in the area of finances also.

The last four years have been the best of my life. God called me to be an Executive Minister in 1985; since then I had been in training and you gave me the opportunity to fulfill God's high calling. Everything I did with ABCORI I did with integrity, passion, and prayer. I have no regrets. I know that I am a better person and a better minister for having served among you.

As you read this report, I am far away in California. My fervent desire for all of you and my prayer before the Lord is that you can be one in Christ, that you can trust one another in ministry, and that you can have the courage to build upon the foundation we have set together.

ELDER CARE MINISTRIES

2010-2011 was a very interesting year for Eldercare. I began the year working as the acting director part time while still pastoring in the North Foster Baptist Church. I was called to the full time director's position and made the switch on June 1, and my installation was on September 19. This has been a year of growth and change for eldercare due to the changing face of the over-65 population, the difficult economy, the spirit of interfaith cooperation, and the formation of coalitions with similar goals.

In May, Interfaith Directors of Elder Advocacy (IDEA) held their first conference. This was a breakfast at the Crowne Plaza called *The Sleeping Giant*. The audience was professionals (clergy and lay) and volunteers from faith communities who are working with seniors. The breakfast was a huge success with 150 in attendance. We were pleased that Bishop Thomas Tobin, Rabbi Peter Stein and Rev. Dr. Donald Anderson were our conveners. The conference covered all types of information that those working with seniors need, including senior spirituality for those in either long term care facilities or are aging in place. It was such a success that we repeated the workshop in October in Spanish (*El Gigante Dormido*). IDEA also ran a successful workshop for caregivers in May called *Promises to Keep*.

I have been working with Senior Agenda which is a watch dog agency for any and all legislation and policies that pertain to seniors. Ethan Adler from Jewish Senior Agency and I presented a workshop in October at their annual conference on Spirituality for Seniors. This workshop emphasized spirituality for the active senior.

I have visited The John Clarke Retirement Center on several occasions and am enjoying a good relationship with the director and the chaplain. I have been asked to lead the Vesper Service in October. The ABCORI staff has joined me on several occasions for a party with all of our Baptist residents.

In lieu of a Volunteer banquet this year, the American Baptist Churches of RI (ABCORI) held a Volunteer barbecue which I helped organize and participated in. Now that I am full time, I am beginning to take over and organize the ABCORI Volunteers as well with the help of Sandra Kelly.

Our Spiritual Care Coordinator resigned effective May 1, 2010. I decided to post the position as two separate positions so there will be three of us tweaking the job description and organizing events. We now have two spiritual care coordinators, Rev. Rosalie Norman-McNaney at Elmhurst and Rev. Ted Platt at Tockwotton.

One of the biggest ABCORI projects that I worked on, along with Coleen Tolhurst, Don Wolfe and Anne Aldrich, was the First Annual Health Fair that was held October 30, 2010.

I have been working with several outside senior agencies on behalf of Eldercare. In January 2011, I became a member of the Board of Directors for Senior Agenda, which is a watchdog agency for legislation related to seniors especially as it related to aging in place. I am still working with IDEA as we plan another conference for this coming spring. I have acted as a consultant and/or a participant for many groups that deal with elder issues: RI Generations (culture change in nursing homes), FIRE (faith infused recover education), Elizabeth Buffum Chase (elder abuse) and Orchard View Nursing Home (helping with hiring a chaplain), SERV RI (active senior volunteers), The Respite Coalition.

Two other near future projects have evolved out of the number of phone calls I get from the ABCORI family who need information about 1) choosing a nursing home for a loved one and 2) having the ability to age in place. There will be information folders that I can share with pastors and the ABCORI family as needed and requested.

2010 ANNUAL REPORT OF THE PRESIDENT

"Consider it pure joy, my brothers, whenever you face trials of many kinds, because you know that the testing of your faith develops perseverance. Perseverance must finish its work so that you may be mature and complete, not lacking anything. If any of you lacks wisdom, he should ask God, who gives generously to all without finding fault, and it will be given to him. But when he asks he must believe and not doubt.... Blessed is the man who perseveres under trial, because when he has stood the test, he will receive the crown of life that God has promised to those who love him."

James 1: 2-6, 12 NIV

The past year 2010-2011 has been something of a trial for our American Baptist Churches of Rhode Island family. Yet it has produced its share of blessings as well; some of them very rich and rewarding.

Let me start with "the trials." This year has seen a significant loss in key staff personnel. In some cases personnel were terminated. In other cases they resigned. The most notable of these were the terminations in July 2010 of our director of administration and our maintenance director. In early January 2011 our executive minister resigned. Each instance brought with it considerable stress and strain.

Our financial picture has also been a source of concern, even anxiety. After several years without any audits of our regular operating books or of our invested funds, audits are now underway in both areas. Preliminary reports are indicating some points for concern, although it appears no improprieties have been found. While final audit reports may not be received until late 2011, it is clear some steps of necessity will be required in order to have a truly healthy financial operation. Some of these steps may even be "hard" for us to take, at least initially.

Our income needs to grow and grow significantly, if we are to do ministry in the name of our Lord. Let me remind us all, that is our **purpose**, **our whole reason to exist: To do ministry in the name of Jesus Christ.** Our camping ministry needs to grow, and by doing so, produce more income to pay our bills, likewise with our conferencing ministry. The potential for the latter to happen will be vastly improved come this June (2011) once our tenant, the Quest Montessori School, has vacated our conference facility. To further help toward this goal, our Operations Team has engaged Rev. Dr. Johnny M. Wilson, Jr., to serve as Development Director on a six month contract basis. It should be said, however, that the key thrust of this position will be to bring in greater "Kingdom Building" dollars. Please be in prayer for our ministries and for the income they can provide to grow those ministries significantly in the future.

While there have been "trials" and moments of "testing", there have been moments of joy, celebration, yes – of rich blessings, as well! While it has been necessary to reshape our staff, it continues to be a source of great blessing to our ABCORI family. The return of Matt Black as Facilities Manager and the addition of Rev. Nikita McCalister as our new Operations Manager (also a six month contract position) strengthen our staff greatly, and give us a truly first rate team to serve us. We have a unique ministry to the elderly, which we've placed in new hands, those of Rev. Marie Carpenter. She and this ministry are truly a blessing within and beyond our ABCORI family. I express my sincere thanks to our entire staff for its superb dedication and service. They truly understand Christ's admonition to be "servants" to God's people.

The task of restructuring and of revising our By-Laws to reflect our new organizational structure is complete, at least for the present. The delegates to our annual business meeting on March 7, 2011, overwhelmingly approved the revised By-Laws as proposed. My deep appreciation goes out to Donna Sherman for seeing this task through to completion, along with her committee, its readers/critiquers, and all who saw fit to approve their work. It should be noted that these By-Laws provide for a fifth ministry team for Camping and Youth Ministries. This should greatly improve the way we do ministry in this area – another blessing!

Our Canonicus property is a real blessing enabling us to do ministry in the splendor of God's mighty creation, and to do it well. Please join me in thanking Don and Linda Hansen for financing construction of a sizable new pavilion, located in Beach Field adjacent to the waterfront. We are blessed by such caring and giving members of our ABCORI family. Thanks to our maintenance staff and Properties Committee and all the volunteers who weekly help with projects on the grounds, so that our facilities and grounds are appealing, safe, and in good repair. There is one "property" concern I feel compelled to address. The old farmhouse, "McCrillis," has been condemned and boarded up. It is a serious safety liability and an eyesore. A decision is needed soon on what to do with this building. It detracts from our ability to do effective ministry.

On the fiscal front, ABCORI, again this year (as last), received a sizable sum of money (in this case, \$40,000) through the sale of former church land to the Town of West Greenwich. A non-Baptist congregation now meeting in the former church building has also expressed interest in purchasing the building and remaining property. Also on the fiscal front, most of our operating manuals have been updated this year. Our thanks to those involved in these efforts.

The "Old-Roots, New Beginnings" series of three informational sessions, spear-headed by our two representatives to the ABC-USA General Board, Rev. Dr. Jonathan Malone and Mr. Antonio Lombardi, along with their Support Team, proved very helpful in connecting our region to the ministries of our national body. In particular, a good number heard our General Secretary, Rev. Dr. A. Roy Medley, speak and share with us in February, 2011. Another rich blessing, indeed!

We are now in a period of transition. I would be remiss if I did not express my gratitude, and I hope, yours, to Rev. Dr. Liliana Da Valle, for her four years of forward-looking ministry among us as our executive minister. She had the foresight to establish a "Transition Team" of nine members to bridge her ministry through the interim period into the tenure of our next executive minister. These folks are each individually responsible for a major area of work normally undertaken by our executive minister. This team is proving invaluable as we move through the process of selecting a part-time interim executive minister and eventually a new, full-time executive minister. We are blessed to have such capable, committed, and caring individuals team up to carry on our affairs in this way. The Transition Team consists of Donna Sherman, Bob Sherman, Joyce Duerr, Cynthia Smothers, Rosalie Norman-McNaney, Jim Miller, Bob Auld, Marie Carpenter, Nikita McCalister, Johnny Wilson, and Sandra Kelly. I know our entire ABCORI family joins me in thanking you for your good work. You are indeed a blessing to us all!

As your President I get to attend a great many and a wide variety of meetings. It has been a real blessing to me to see so many different faces as I move from meeting to meeting. ABCORI is richly blessed by so many caring and dedicated volunteers serving on its Ministry Teams, on its committees, Task Forces, let alone, as servers at dinners, greeters at functions, planners of events, consultants to our churches, and so much more. Thank you all for your commitment to building the Kingdom in this place. We are blessed!

My thanks to my fellow officers and Board of Ministries' members who have served these past two years, and who now leave their positions, hopefully to do ministry in new and different ways. My warmest regards, highest respect, and very best wishes to the very gifted Donna Sherman as she assumes the duties of President. Thanks to you all for your faithfulness to and support of ABCORI these past two years. It is truly the richer for your caring, your prayers, and your participation in its great mission.

I trust that those "trials" we have experienced together have strengthened our "perseverance" that we might "mature and be complete" in the Lord. May we be the wiser from our experience and better equipped to minister in the name of our Lord. May our perseverance prove to be a rich blessing, not so much for us individually, but for our collective ministries in the name of Jesus Christ.

May the Lord richly bless each of you! Amen.

STANDING COMMITTEE ON ORDAINED MINISTRY (SCOM) 2010-2011 Annual Report

The Standing Committee on Ordained Ministry (SCOM) meets on the first Thursday of each month to address the ongoing issues of professional ministry – both in the preparatory stages leading to ordination and after ordination to promote healthy pastor/church relationships and, when necessary, to deal with questions of ethics or clergy misconduct. SCOM is charged with maintaining ministerial standards and discipline; coordinating pre-ordination licensing; overseeing the ordination process; and providing continuing education and counseling referrals for clergy.

The committee has four teams that focus on specialized areas:

- *In-Care*: Provides guidance for candidates who have received their pre-ordination licenses and are now preparing for ordination. Each candidate is assigned an in-care pastor and must meet a standard list of criteria.
- Interim Ministries: Establishes and provides oversight for effective interim ministries in ABCORI.
- *Ministerial Health*: Coordinates educational opportunities and assumes responsibility for conducting misconduct investigations and following through with ethical issues that may arise. Also works with clergy from other denominations who seek to have their credentials/ordination recognized by ABCORI.
- *Ordination Procedures*: Works with the candidate and the ordaining church to conduct the council and the ordination service.

Candidates currently under care in preparation for ordination are Doris Hooks, Adam Kyne, Kyle Larguinha, Rebecca Law, Lemeck Louis, Virginia O'Shan, Irving Scoby, Michelle Sullivan, James Whitney, and Lee Williams.

- 3. **Ministers Council** holds at least four programs, usually on the fourth Thursday in November, January, February and March. Contact Marie Carpenter (President) or (Program Chair)
 - Fall retreat is held at Canonicus on a Tuesday in October
 - Block Island Retreat is held the second Tuesday in May (25 or more participated in 2010)
- **4. RI State Council of Churches** (RISCC) planning a Fall 2011 event regarding end of life issues, through the RI Attorney General's subcommittee. Contact: Rev. Bob Auld
 - Clergy name tags are available though the RISCC office

Continuing Education:

- 1. **Providence Bible Institute's Lay Ministry:** Bob Auld and Liliana Da Valle met with its director Rev. Israel Mercedes and were promised five registration openings for the fall of 2010. We have exceeded that number and the participants report a very rewarding experience!

CONGREGATIONAL LIFE MINISTRY TEAM Annual Report

Annual Gatherings

Planning annual gatherings is a major responsibility of the Congregational Life Ministry Team (CLMT). A three-year theme was launched at the 2009 Annual Gathering, "Kingdom Under Construction: *Building Hope*, Building Faith, Building Future".

Annual Gathering 2010 (AG10) continued the 2nd phase of the three year theme and focused on "Kingdom Under Construction: Building Hope, *Building Faith*, Building Future". Deb Guilmain, CLMT member and Youth Ministry Planning Team (YMPT) liaison, helped as YMPT took an even more active role in the overall planning of AG10. Youth had their own ministry track, but joined with the adults for parts of the program. Another overnight retreat was planned and carried out for the youth. Several 'Faith Builder' groups provided opportunities to learn and grow in faith and discipleship. Rev. Dr. Kirk Jones was the keynote speaker. His message was timely and challenging. Congregational Life reluctantly says 'farewell' to some of our team members who worked in this area, and promises to pray for them as they develop camping and youth ministries.

SOCIAL WITNESS MINISTRY TEAM Annual Report

One of our first projects was to promote a *Children in Poverty* initiative encouraged by Rev. Dr. Liliana Da Valle. Through funding resources entrusted through ABCORI, a successful full day conference was again held at the Roger Williams Park Casino, through the efforts of several poverty agencies and the Rhode Island Interfaith Coalition. It was well attended. There were workshops and a lively debate among the gubernatorial candidates.

During 2010 our team has promoted the social witness activities of other ABCORI churches through the ABCORI E-notes news letter and by networking. We have attempted developing a social witness directory, listing activities and programs of other ABCORI churches.

For now we plan to utilize the ABCORI E-notes and to initiate a system of sending electronic announcements to ABCORI churches via *constant contact* in order to accomplish the following:

- 1. Raise awareness among ABCORI churches that the Social Witness Ministry Team is available to help them identify helpful resources as they plan social witness ministry initiatives.
- 2. Inform our churches about social witness initiatives and events that are taking place at individual ABCORI churches so that other churches can support them.
- 3. Inform our churches about other social witness initiatives and events in Rhode Island that are sponsored by the RI State Council of Churches and other groups so that their congregations can participate, if desired.

We also hope to promote awareness of social witness ministry opportunities by hosting workshops at future ABCORI Annual Gatherings, offering resources for planning social witness initiatives and high lighting successful social witness events that have been carried out by other ABCORI churches. Another possibility is to co-sponsor workshops with other groups, such as the Baptist Peacemakers of RI, on a variety of peace and justice issues.

OPERATIONS 2010 ANNUAL REPORT

2010 has been a difficult and busy year for the Operations Team. Our income did not meet either the levels of years past or our expectations of 2010. Canonicus Camp and Conference Center suffered a disappointing camping season, with attendance well down below previous years, and use of the conferencing center was also lighter than hoped. These events combined with somewhat lower United Missions giving resulted in \$130,000 less revenue than expected. Expenses were down from last year which helped control the deficit. On a positive note, the constrained fiscal situation demanded tighter controls which were developed and are now in place. As a result, this year has been a struggle to maintain the mission of ABCORI while not draining our investments too severely. In this objective I believe we were modestly successful.

The Operations Team oversees many of the resources of ABCORI: financial, property, personnel, investment, and fundraising. You will hear of the efforts of each of these areas in their separate reports, but I would like to highlight some of their achievements.

<u>Properties</u> had a very busy and productive year providing major maintenance to several of the buildings and equipment. They also provided oversight for the construction of a new beachfront pavilion, the cost of which is a generous gift by the Hansen family.

<u>The Baptist Fund of Rhode Island</u> has been active in loaning funds to churches that needed renovations to meet the new fire codes. It also provided timely assistance to United Baptist Church in Newport through short term loans for needed repairs.

<u>Budget</u> has done great work in the effort to review and contain spending to match actual revenues. The committee conducted quarterly reviews of the budget to measure compliance. As a result, we have managed to preserve most aspects of the ABCORI mission without exceeding our income by more that was authorized.

<u>Investment</u> has initiated a major review of the Pooled Funds and instituted new policies to guide our investments. The funds themselves have enjoyed growth over the benchmarks in this recovering market.

<u>Personnel</u> has been busy reviewing and revising the personnel policy manual. This effort has resulted in a newly revised Employee Manual that is awaiting approval by the Board of Ministries. Along with this effort new job descriptions have been developed for each staff position and reviews of health care options and other benefits have been done.

ABCORI is fortunate to have had the support of many members who, in past years, generously contributed to the ABCORI endowment. These gifts are what enable us to meet our goal and continue our mission in these down times. We need the continued generosity of our members to maintain a healthy financial status and to insure ABCORI's future. Camp for our youth, support for our ministry, and advocacy through both local and international missions are what we are about. The Operations Team is pleased to provide the underpinning to these endeavors. We are grateful for the support of all of Rhode Island's American Baptists as we do our job Thank you all.

BAPTIST FUND OF RHODE ISLAND (BFRI) 2010

During 2010 BFRI continued supporting the program life of American Baptist Churches in Rhode Island through grants and loans funded by endowments specific to the BFRI ministry, as well as interest and loan repayments, and most importantly, the annual financial support of ABCORI congregations. In addition to providing annual budgeted grants to community "PARTNERS IN MINISTRY", grants were made to provide seed money for new ministries or to improving existing ministries, as well as to pastors in crisis. Significant this year was the need for BFRI to step in with loans to churches hard pressed financially to comply with state and local fire code upgrades mandated in the wake of the Station nightclub fire. Without gifts of farsighted donors in past years to designated funds for this ministry, churches would have had difficulty securing the financing required for these major undertakings. In addition, through two short-term loans to United Baptist Church of Newport, that congregation was enabled to secure from trusts and foundations major grants for the repair and restoration of the ceiling of their historic sanctuary. At the December 12, 2010 community and congregation celebratory service, United Baptist presented a Certificate of Gratitude and Appreciation to BFRI, stating "the emergency loan that was granted to our congregation gave us the ability to move forward in a timely fashion with this project."

The gratitude of those who receive support through BFRI does not reflect to the persons who serve on the BFRI committee, but rather to you who through your congregation's financial support of BFRI enable the committee to serve in your name. Information is found on the ABCORI Website – BFRI link. We appreciate all who serve on the committee and we are especially grateful for the service of Randy Lundquist, treasurer. Thanks to each for sharing your wisdom in the carrying out of the fiduciary responsibility of BFRI.

INVESTMENT COMMITTEE 2010

The Investment Committee oversees the investments of the ABCORI Pooled Fund Portfolio. The value of our Portfolio as of December 31, 2010 was as follows:

Combined Pooled Fund value as of 12-31-2010 \$6,425,185.00

The portfolio has enjoyed a significant rise in value wiping out a major portion of our unrealized losses in 2008-2009. We are pleased with the efforts of our investment manager, Alliance Bernstein, to maximize the portfolio in such a way as to bring back its value without taking any extreme risks. We have discussions with them quarterly to review the portfolio and market conditions. Our policy of investing 10% of the portfolio on a 5% trailing average into local community economic development projects continues to perform. However, we have noted some deterioration of investments in this area and are taking action to limit our exposure until we get back into more stable times.

On advice of our investment advisors, we converted some of the portfolio (30%) into an overlay product which gives us more protection from wild swings in the market. This product has worked well for our portfolio. We are quite pleased with Bernstein Global Wealth Managements performance in achieving a total return of 10.2% for 2010. The Investment Committee decided to maintain our draw rate of 4.5% for 2011. However, the effect of the market drop in 2008 continues to be a drag on our three year trailing average used to compute the dollar amount of the draw.

Bernstein Global Management is performing well as our custodial agent. NRS, a specialist in servicing the accounting end of non-profit portfolios, is providing excellent service. This year we changed our method of delivering the quarterly checks. The quarterly statements and checks are mailed directly by NRS to our members. We hope this process will provide quicker delivery of the funds to our clients. Please keep us advised of any problems in this area.

The Investment Committee has engaged the services of AMS (Accounting Management Solutions) to review the portfolio with regards to UPMIFA (Uniform Prudent Management of Institutional Funds Act) and will complete this project in April. We will report their results and possible rebalancing of the Portfolio in May.

We are planning to hold a Pooled Fund Investors' dinner meeting in late May. Bernstein will be presenting an overview of the portfolio performance and a look into the future. Invitations will be sent out.

During 2010 Peter Gustafson, Whitney Bancroft, and Charlie Ward resigned from the committee. Even though they resigned from the committee, they are still involved with the camp in many ways, our thanks to them for their work and dedication. For 2011 we welcome Holly Swift (First Baptist, East Greenwich) to the property committee.

Work days were held several times during the year. The Raiders, working with the Facilities Manger, have worked nearly every Monday throughout the year, as has been the case for many years.

This year has been a year of change. With the change of leadership at ABCORI and Canonicus, the properties committee has kept its focus on the upkeep and improvement of Canonicus.

Highlights of accomplishments include:

A new pavilion has been built in the Beach Field. Our grateful thanks to Don and Linda Hansen, who were the benefactors for this project, as well as to Greg Pawlina, who oversaw the project.

A camp inspection calendar was initiated and we will be doing a complete inspection of the camp on a two year rotation. Using those results, we will be able recognize issues and set priorities for repairs.

Many other jobs are on our agenda for the future. Some jobs have been on the agenda for some time and others are added weekly.

ABC-USA GENERAL BOARD REPRESENTATIVES' REPORTS - 2010

Rev. Dr. Jonathan Malone - Nationally elected representative to the General Board

2-16-11 It has been a privilege to serve as your representative to the General Board along with Antonio Lombardi this past year. Besides being on the General Board, ABC-USA, I am on the Committee for Christian Unity, and on the board of directors for the American Baptist Home Mission Societies. This report will address each aspect of my responsibilities.

Committee for Christian Unity – The CCU works with various Baptist groups in the nation and the world including the Baptist World Alliance and the New Baptist Covenant, ecumenical groups in the nation and the world including the National Council of Churches, the World Council of Churches, and emerging interfaith conversations. While doing all to be sure that ABC is well represented in the Baptist and ecumenical groups, the CCU is a strong part in pushing a Baptist-Muslim dialogue in the nation. In October of next year the CCU will be a partner in hosting the second national conversation at Andover Newton Theological School. In addition, the CCU had a representative at the recent Lausanne Congress bringing ABC-USA in close working and conversation with other evangelical groups in the world. In this group good work of unity and cooperation is happening for the sake of peace, justice, and mercy through the name of Christ.

American Baptist Home Mission Societies – The ABHMS (formally know as National Ministries) is in the process of considering how to continue doing important work among American Baptist churches in the nation while at the same reaching a budget that does not draw on endowments and works efficiently. Because of ABHMS bylaws already passed, pending an adoption of the bylaws for ABCUSA, the board of directors will be reduced in size for the sake of flexibility and efficiency.

As that change is on the horizon, the Executive Director, Aidsand Wright-Riggins, is leading the way for a change in view, vision, and ethos of the ABHMS. Briefly, the ABHMS is moving away from considering how to continue to survive and do the work of ministries to seeing how it can serve churches and the ministries already happening within and among churches. The ABHMS is here to serve us.

The General Board of the ABC-USA – The General Board is actively preparing present rewritten bylaws so they can be voted on by church delegates in Puerto Rico this summer. It is heartening to know that many of the critiques made in Pasadena concerning the bylaws were heard and influenced many of the changes made. For the sake of space, I will not delve into the details of the by-laws and the changes (although just ask and I will be happy to confuse you with the details).

From my own perspective, I originally voted against the bylaws, because of the many flaws that were pointed out in Pasadena. Today I am not completely satisfied with the content in the bylaws or the process by which they were produced. Yet with that said, I am not confident that voting against these changes again would be in the best interest for the denomination and the work of Jesus Christ. I feel that the denominational leadership has done the best that they could and with trust in God, we should embrace the changes so we all can go forward in doing the Lord's work. Between now and the Biennial, I hope to elicit the ideas, the will, and the passion of the people in the pews of ABCORI so that I can represent the region on the General Board.

Other and Summary – Antonio and I are continuing our series of "Old Roots, New Branches" which has been a very good process. We owe a great debt of gratitude to our support team in these efforts. As we look forward to our final events of Old Roots, the next challenge before both of us is sharing the work of the national program boards and the possible changes that are before us in Puerto Rico. I am not naive to the difficulty of the nature of this, but feel that it is an important task for the sake of the denomination and to encourage possibilities to share and engage in the ministry of Jesus Christ.

Finally, I have been reminded of the story we have to tell as Baptists. It is a story that is exciting, that merits pride, and that continues to call us to face the challenges before us. The story begins with the local church, is enhanced through the work of our regional staff, and continues through the support of our national denominational program boards. It is with great humility that I strive to represent American Baptists of Rhode Island on the national level.

AMERICAN BAPTIST WOMEN'S MINISTRIES OF RI Annual Report for the year 2010

Through American Baptist Women's Ministries, women and girls have opportunities to worship God, grow spiritually, develop spiritual gifts, care for one another, and reach out to others.

The program and financial year for AB Women's Ministries of Rhode Island is July 1 to June 30. Each winter we have a Spiritual Growth Retreat. In 2010 we participated in the all New England States Retreat for women and AB GIRLS held in Massachusetts. In February 2011, forty-eight Rhode Island women and girls participated in the retreat at Canonicus.

We have statewide gatherings that give women the opportunity to learn about our American Baptist mission efforts in this country and around the world, and address issues of particular concern to women and children. In March 2010, we met at Calvary Baptist Church and put mission into action as we hosted a Fun Fair for area families - complete with crafts, games, prizes and food. We also prepared 97 health kits for Church World Service for Haiti earthquake relief. In October, Olney Street Baptist Church hosted our state gathering where women and AB GIRLS explored "Walking in Their Shoes" and heard Peggy Burke, national ABWomen's Ministries officer, share her experiences in Haiti; honored women in whose footsteps we follow with gifts to the national AB Women's Ministries Endowment Fund; worshiped with liturgical dance; and cut 800 cotton squares for medical use in the Democratic Republic of the Congo.

We are looking forward to the annual spring conference on June 3-4, 2011, at Canonicus with the theme *AB Women: How Are We Growing and Blooming?* There will also be a program for AB GIRLS welcoming all girls in grades 4-12. At the 2010 conference we explored a Christian's response to human trafficking and other issues facing women and we launched our new state project *Power Up!* to raise \$2,000 for computer needs at South Providence Neighborhood Ministries.

We celebrate what women in our churches are doing in many various forms of ministry – food pantries, visitation, knitting, and so much more. We encourage both those with and those without local organized women's groups to join in our state activities. We encourage girls to participate in AB GIRLS activities. We can benefit from each other's experiences and shared ideas.

Through White Cross, women in our churches are major supporters of our various mission endeavors. They purchase toys, socks, gifts, school supplies and more for South Providence Neighborhood Ministries; they provide baby blankets, bandages and surgical supplies for hospitals in Congo; they prepare hundreds of school, baby and hygiene kits for Church World Service; and they make financial contributions for medical and educational work overseas. Love Gift offerings support our denominational mission efforts, as well as ABCORI, through United Mission. We continue to lift up the issue of human trafficking and support efforts to bring international attention to ending this modern day slavery.

REPORT OF BAPTIST HOME BOARD FOR 2010

The Baptist Home Board of Rhode Island (BHB) is a charitable corporation whose incorporators consist of delegates to the annual meeting of the American Baptist Churches of Rhode Island (ABCORI). BHB officers and directors are elected at a separately convened meeting customarily held during the annual meeting of ABCORI. The principal obligation of the board of directors of the corporation is the prudent investment of a substantial endowment and the thoughtful use of these resources in accordance with its charter.

In 2010 as in prior years, one of the major recipients of these funds was John Clarke Retirement Center, who used the funds received from Baptist Home to provide chaplaincy services there, some nursing services to retirement home residents, security and transportation services, and other benefits expressly for American Baptists residing in the retirement center.

ABCORI was the other major recipient and those funds were used to support its Elder Care Ministries. During 2010, Marie Carpenter became ABCORI's new director of Elder Care Ministries and she has continued the fine work of her predecessor, Kathy Black. The Baptist Home is pleased to be able to make this ministry financially possible. It is a rare program among Protestant denominations and an ecumenical approach to the spiritual needs of the elderly in Rhode Island, particularly in nursing homes.

Additionally, a limited amount of money is made available to ABCORI churches for special needs of the elderly within the church building.

BAPTIST HERITAGE ANNUAL REPORT 2010

The purpose of the Rhode Island Baptist Heritage Center is to help our American Baptist Churches of Rhode Island (ABCORI) to connect the past with the present, ever looking to share the Gospel of Jesus Christ with each generation of the future.

In 2010 we met about every other month at Canonicus and worked to fulfill our stated purpose in a variety of undertakings.

First, we began to plan the 2011 Baptist Heritage Weekend to be held on November 5 & 6. This year's theme will focus on contemporary issues of the separation of church and state. Our key note speaker will be Melissa Rogers. Currently she is the Director of Wake Forest University Divinity School's Center for Religion and Public Affairs and has served as Executive Director, Pew Forum on Religion and Public Life; General Counsel, Baptist Joint Committee on Public Affairs.:

Second, in conjunction with Standing Committee on Ordained Ministry, we have designed a Baptist Polity Course for those seeking ordination or ministerial standing through ABCORI and who are unable to take such a course in one of our seminaries. It should also be noted that while the course seeks to fulfill the requirement for ordination or ministerial standing, it is also being designed for anyone in our churches who wants to learn more about our Baptist way of life and faith. The outline of this course is as follows:

Baptist Polity Course, American Baptist Churches of Rhode Island

- ♦ The Scope of the course will include Baptist History, Core Baptist Beliefs, Polity and Denominational Structure
- There will be three sessions held at three locations. Each session will last 4 to 6 hours.

The Schedule of the Sessions

- 1. History to be held at First Baptist in America
- 2. Practice and Baptist Principles to be held at United Baptist Church Newport
- 3. Denominational Connections (structure, etc) ABCORI Office
 - There will be prerequisite reading that will need to be completed before each session.

The Required Core Texts for the Course

- 1. Four Fragile Freedoms Walter Shurden
- 2. A New History of Baptist Principles William Brackney
- 3. Liberty of Conscience; Roger Williams in America Edwin Gaustad
- 4. The Legacies of John Clarke Sydney James
- 5. A Baptist Manual of Polity and Practice by Hudson & Maring or The New Hiscox Guide for Baptist Churches edited by Everett Goodwin
- 6. *Baptist Convictions* Winthrop Hudson (Please Note: This list is not finalized as we are looking into other resources as well)
- Mastery of materials presented will be determined through written assignments, class participation and a final oral exam.

Third, we have established a file cabinet in the Motter Resource Center at Canonicus. The purpose of this file is to provide a central resource that uplifts our RI Baptist Heritage. At the present the file holds the minutes of our meetings and a variety of papers that have been written by board members on our RI Baptist heritage. Additions of individual works on Baptist history, theology and life and individual church histories of our ABCORI congregations will be gladly accepted and put on file. To make a submission, contact me at UBCNPT@verizon.net Fourth, we have revised the little booklet – *Rhode Island: Hometown Baptists in America*. This brief work is a good resource that provides a concise history of our heritage from 1637 to the present day. The publication of this revised work for distribution will be in time for the Annual Gathering in late April, 2011.

Finally, with the approval of the family, we have arranged for the papers and sermons of the Rev. Dr. Homer Trickett to be deposited in the John Hay Library of Brown University.

FINANCIALS 2010

COMMENTARY ON 2010 YEAREND FIGURES - March 4, 2011

Again, the total revenues of \$771,069 fell short of the 2010 budget this year by \$137,122. The retreat fees were short by \$44,670, plus the \$12,000 from the Board of Ministries (BOM) challenge project, United Mission by \$15,641, and summer camp fees by \$50,487. Declining revenues continue to be a problem and are putting stress on the functioning of the American Baptist Churches of Rhode Island. Total expenses of \$1,031,097 were slightly over budget by \$9,958. There are no notable exceptions in the expenses above or below budget, but the expenses were not reduced to keep pace with the declining revenues.

The yearend net after endowment draw was \$110,028 expenses over revenues. The BOM approved approx \$90,000 of this at its December 2010 meeting. This year, accruals were taken at yearend to better align the revenues and expenses. This action increased the December expenses beyond expectations and accounts for the cash difference, because expenses were booked, but cash was not expended.

Recommendations are that WE HAVE AN ALL OUT PUSH FOR INCREASWED REVENUES. Primarily, this has to be a VOLUNTEER effort to leverage the efforts of the staff and consultants. The challenge to the BOM (taken last year) did not materialize to help us meet the budget. Secondly, expenses need to be brought into line with revenues more quickly. This is especially true for summer camp and Canonicus usage in general. Thirdly, we need to be creative in utilizing Canonicus Facilities.

COMMENTARY ON ADJUSTED 2011 BUDGET—March 4, 2011

The Board of Ministries (BOM) approved the 12/14/10 draft of the 2011 Budget, but major changes have occurred, which impact that adopted draft. The new ABCORI ANNUAL BUDGET – 2011presented March 7, 2011(and printed in this book) had the following additional inputs:

Revenues – Quest will vacate the conference center at the end of this school year; therefore, the rent was reduced from \$63,000 to \$24,000. Kingdom revenues were increased from \$30,000 to \$50,000 due to the engagement of a development contractor. United Mission was increased from \$101,000 to \$125,000 to match historic giving levels. Gifts were increased from \$6,000 to \$10,000 as a better estimate. Summer camp fees were increased from \$81,000 to \$156,500 to match the co-camp directors' proposed budget. Eldercare grant revenues were reduced from \$147,965 to \$135,000 to match their budget numbers. The total revenues increased by \$67,035 to a total of \$880,800.

Expenses – Eldercare expenses of \$134,995 match their budget. Auditing and legal fees were increase from \$16,000 to \$33,560. Maintenance contractual services were reduced by \$4,000 to \$18,000. The personnel costs added \$58,000 for the new consultants and \$4,500 for the Transition Team expenses. Professional wages were reduced from \$44,108 to \$12,000 to reflect current cost. Overall, the personnel costs were reduced from \$534,120 to \$474,153 which is a savings of \$59,967. Unusual expenses were reduced from \$23,000 to \$20,000 to better reflect estimates. The total expenses were reduced by \$50,407 from \$1,025,670 to \$975,263.

Net – The budget adopted by the Board in December had a loss, after draw, of \$119,875. The adjusted budget has an excess of \$10,532. This is a conservative budget, but the increase of \$80,000 in revenues must occur to prevent shortfall. As noted in the yearend 2010 commentary, there needs to be an all out effort to reach projected revenue goals.

Commentary – This adjusted budget is still conservative; but it should be noted that should an Interim or Actual Executive Minister be hired, the expenses will need to be added into the budget. The consultant's contracts only run for six months as well. Their costs would need to be added to this adjusted budget should the contracts be extended.

Dr. Alexander alluded to the fact that 2009 was a very tough year, requiring very painful cuts, especially those that involved personnel.

A motion was made to approve the Treasurer's Report as printed; the motion was seconded. The motion carried.

Dr. Alexander stated that the budget required a lot or work and a lot of review; however, the staff believes it is realistic and workable. While the Human Resource cuts were very painful, we have experienced the anticipated savings. He asked Don Wolfe to give a highlights of the budget review:

Don stated that at the end of February, a review was done to see what we can learn.

- Largest problem was the retreat fees were below budget
- ♦ United missions were up \$13k Kingdom Building brought <\$16k
- June-September expenses were cut dramatically but sadly we also needed personnel cuts
- Cut personnel services by \$68k

- ♦ Expected 09 to be \$65k over budget ...actually came in \$100k requiring us to draw from endowment in order to balance the budget
- Can't repeat this year after year

A question was asked about the monies from the Sale of No. Tiverton Church; those revenues were returned to the Endowment in 2009.

A Motion was made to adopt the budget for 2010; the motion was seconded. The budget is adopted.

She stated she is having fun working with all who are the volunteers of this organization; what you do, you do with love and commitment...and I really appreciate it. She outlined four programs of top priority:

- 1. Pastoral approach with our pastors I try to be there for them to support them.
- 2. Work with consultants for pastoral searches; Rev. Dr. Bill Crawford has been added to work on Special Projects in our region on a volunteer basis.
- 3. Kingdom Building personal visits
- 4. Colonel Dean Esserman, Chief of Police of the City of Providence asked to set up a chaplaincy program. He came to us; he trusts us; we are recognized us as a moving force in our state.

Many of the programs were highlighted, especially a new program for children who are on school vacation coined as "Campcation." The program was very successful and totally volunteer driven.

She reiterated the difficulty in making necessary cuts to human resources. Property maintenance is being done on a "high need" basis only to maintain cost savings.

Quest Montessori School has purchased their own building and will be moving out of our facility by the Fall of 2011. This will allow the use Schaub for conferences which should help revenues. Calls are being made by the staff to the local churches to provide them with information on what facilities and services are available to them. Volunteers are always needed!

Rev Dr. Tony Pappas from TABCOM – spoke on the challenges to New England; is the least religious place in the US – the hardest place to share your faith.

Is the Lord giving us the opportunity to work on spirituality? Isaiah 11:1 tells us:

"God shall raise a shoot from the stock of Jesse and a branch shall spring from his roots." God is ready to send us something new!

He recently returned from a trip to Bangladesh where he saw first hand the American Baptist programs called Symbiosis, established prior to a law being passed disallowing missionary work to be done in this country.

AB Missionaries have taught the women literacy, health, child care, financial management, basic rights, cooking. The women have created small businesses (Tea Room, small Cakes, Sewing) and are now able to provide for their own families. They even run their own Credit Union so they can loan their monies to other women who wish to start small businesses. The credit union is so well established and respected, people outside the small community are beginning to put place money into it as well.

The main subsistence food for these people is rice. One woman asked "what is the basic subsistence food in America?" They could not comprehend the variety of food we take for granted. Let it encourage us to be thankful to our God for the variety of foods we have.

Hank thanked everyone for allowing him to have these great learning experiences during his service on the Boards. He also asked that we support our new delegates, Rev. Jonathan Malone and Antonio Lombardi. He also thanked everyone for their fellowship and friendship to him and his wife.

Nancy Bancroft made a motion to affirm the appointment of the Bylaws Review Committee appointed by President James Essex, consisting of Peggy Johnson, Donna Sherman, Richard Pierce, Nancy Bancroft, Liliana DaValle, and others as needed, that will recommend changes to reflect our new structure, and that ABCORI continue to work under the present version of our bylaws, with portions set aside, until the 2011 annual business meeting when bylaw recommendations will be considered. COVENANT OF RELATIONSHIPS Preamble

The American Baptist Churches of Rhode Island offers this Covenant of Relationships in the hope of enriching the individual congregations of this State and the organization through which we endeavor to work.

As Baptists, we strongly affirm the worth and integrity of the local congregation of believers as a true church and a community of faith. Yet, we recognize that as churches working together in mission, we have responsibilities to one another which we fulfill through associating freely in larger societies, which are themselves, expressions of the church. This Covenant of Relationships outlines basic areas in which we carry out our responsibilities to one another through the American Baptist Churches of Rhode Island, and in which that body carries out its responsibilities toward the individual congregations. This relationship has not been well defined in the past. Our constitution speaks only of "associating" churches, and defines such a church as:

"an American Baptist church which has covenanted to become a constituent member of the corporation and which has been accepted for such membership by the Annual Meeting of the American Baptist Churches of Rhode Island or its Board of Mission."

(III, A, 2)

This Covenant is not to be seen as a strict set of rules to determine every possible aspect of a relationship. Rather, it is a Covenant about a relationship, within which the partners have room to grow and contribute their own unique strengths and gifts. It is in that spirit that this Covenant of Relationships is offered, and it is hoped that in that spirit it will be accepted, so that our congregations may grow in our common mission as followers of Jesus Christ.

]

The American Baptist Churches of Rhode Island covenants to:

- A. Manifest a pastoral concern for each congregation through periodic visits by officers and staff
- B. Concern itself with the welfare and well being of all the churches of the corporation
- C. Provide placement counseling for pastors and other church staff and aid congregations seeking to fill ministerial and other staff vacancies
- D. Provide a nurturing fellowship among the agreeing churches and pastors
- E. Provide information about pastoral development and programs of continuing education
- F. Produce and distribute annual reports concerning the work of participating congregations and related organizations
- G. Provide meetings for inspiration, conducting business, resourcing, sharing concerns, and receiving information
- H. Provide resources and training for ministry
- I. Provide information on a regular basis concerning the ministries of the American Baptist Churches of Rhode Island
- J. Respect the freedom of the local church to order its inner life and determine its own relationships
- K. Represent and appoint representatives from ABCORI to state ecumenical associations
- L. Provide a nurturing atmosphere for and maintain contact with members of individual congregations who are preparing for the ministry.

II

The individual congregations covenant to:

- A. Accept the stated purpose of ABCORI as recorded in Article II of the Constitution and Bylaws
- B. Support the "United Mission Basics" of American Baptist Churches/USA by contributing responsibly
- C. Welcome opportunity for fellowship and consultation with the staff and officers of ABCORI
- D. Take an active part in the work of ABCORI through delegate representation
- E. Be a strengthening fellowship by encouraging and supporting neighboring churches
- F. Participate in applicable programs and use resources supplied by ABCORI
- G. Provide for continuing education for professional church leadership
- H. Give consideration to the use of ABC/USA educational and missionary materials
- I. Work in a cooperative spirit with the American Baptist Churches of Rhode Island to nurture those members preparing for the ministry.

The individual congregations covenant together in mutual ministry to:

- A. Be in fellowship by encouraging and supporting sister churches
- B. Communicate with each other in times of joy and grief
 C. Work cooperatively for strength of witness in ministry and mission
- D. Be in prayer for one another.

COVENANT AND CODE OF ETHICS FOR PROFESSIONAL CHURCH LEADERS OF THE AMERICAN BAPTIST CHURCHES IN THE U.S.A.

Having accepted God's call to leadership in Christ's Church, I covenant with God to serve Christ and the Church with God's help, to deepen my obedience to the Two Great Commandments; to love the Lord our God with all my heart, soul, mind and strength; and to love my neighbor as myself.

In affirmation of this commitment, I will abide by The Code of Ethics of The Ministers Council of The American Baptist Churches and I will faithfully support its purposes and ideals. As further affirmation of my commitment, I covenant with my colleagues in ministry that we hold one another accountable for fulfillment of all the public actions set forth in our Code of Ethics.

MY CODE OF ETHICS

- † I WILL hold in trust the traditions and practices of our American Baptist Churches; I will not accept a position in the American Baptist family unless I am in accord with those traditions and practices; nor will I use my influence to alienate my congregation/constituents or any part thereof from its relationship and support of the denomination. If my convictions change, I will resign my position.
- † I WILL respect and recognize the variety of calls to ministry among my American Baptist colleagues, and other Christians.
- † I WILL seek to support all colleagues in ministry by building constructive relationships wherever I serve, both with the staff where I work and with colleagues in neighboring churches.
- † I WILL advocate adequate compensation for my profession. I will help lay persons and colleagues to understand that professional church leaders should not expect or require fees for pastoral service from constituents they serve, when these constituents are helping pay their salaries.
- † I WILL not seek personal favors or discounts on the basis of my professional status.
- † I WILL maintain a disciplined ministry in such ways as keeping hours of prayer and devotion, endeavoring to maintain wholesome family relationships, sexual integrity, financial responsibility, regularly engaging in educational and recreational activities for professional and personal development. I will seek to maintain good health habits.
- † I WILL recognize my primary obligation to the church or employing group to which I have been called, and will accept added responsibilities only if they do not interfere with the overall effectiveness of my ministry.
- † I WILL personally and publicly support my colleagues who experience discrimination on the basis of gender, race, age, marital status, national origin, physical impairment or disability.
- † I WILL, upon my resignation or retirement, sever my professional church leadership relations with my former constituents, and will not make professional contacts in the field of another professional church leader without his/her request and/or consent.
- † I WILL hold in confidence any privileged communication received by me during the conduct of my ministry. I will not disclose confidential communications in private or public except when in my practice of ministry I am convinced that the sanctity of confidentiality is outweighed by my well-founded belief that the parishioner/client will cause imminent, life-threatening or substantial harm to self or others, or unless the privilege is waived by those giving the information.
- † I WILL not proselytize from other Christian churches.
- † I WILL show my personal love for God as revealed in Jesus Christ in my life and ministry, as I strive together with my colleagues to preserve the dignity, maintain the discipline and promote the integrity of the vocation to which we have been called.

American Baptist Churches of Rhode Island CONSTITUTION AND BY-LAWS

Preamble

- We, the American Baptist Churches of Rhode Island,
- Committed to the prayerful faith that all persons are dependent upon God, the Giver and Sustainer and Redeemer of life,
 and that we may most please God by accepting Jesus Christ as Lord and conforming our lives to His Spirit and way; and
- Believing that though each congregation of believers is a true church, a community of faith, our larger life as American Baptist Churches of Rhode Island is also a form of expression of the church. It partakes of churchly character and performs churchly functions, and is thus an agency for the mediating of divine grace, for the enabling of the Holy Spirit to work, and for preaching of the Gospel among all people; and
- Having freely associated ourselves together as local congregations for the more perfect obedience to Christ's command and
 the carrying out of His mission in the world, we do adopt this Constitution as descriptive of the way in which we order our
 common life as American Baptist churches in Rhode Island.

ARTICLE I - NAME

The name of the Organization shall be American Baptist Churches of Rhode Island (hereafter may be identified as ABCORI). It is an organization incorporated in the State of Rhode Island and Providence Plantations and recognized under section 501 (c) (3) of the United States Internal Revenue Code of 1954 as exempt from taxes being a non-profit religious organization.

ARTICLE II - PURPOSE

The American Baptist Churches of Rhode Island is an expression of the universal Church of Christ. As a creation of local congregations of Christian believers, it becomes an extension of their life, their work and their witness in and to the world. The American Baptist Churches of Rhode Island shall establish, maintain and assist American Baptist churches in the state. It shall relate its local congregations to each other, the American Baptist Churches in the USA (hereafter may be identified as ABC-USA) and to other Baptist bodies such as the Baptist World Alliance. It also shall promote the cooperation of Baptists in Rhode Island with other Christian believers, looking toward a greater unity in Christ's Body, the Church.

ARTICLE III - POLITY

Ultimate authority for the American Baptist Churches of Rhode Island shall reside with the voting delegates of its constituent members and voting members of the Board of Ministries assembled at the Annual or any Special Meeting.

ARTICLE IV - MEMBERSHIP

SECTION A. CONSTITUENT MEMBERS

- 1. The associating churches of ABCORI shall be deemed constituent members of the corporation.
- 2. An associating church shall be an American Baptist Church which has agreed to become a constituent member of the corporation and which has been accepted for such membership at an Annual Meeting of the American Baptist Churches of Rhode Island or its Board of Ministries. The nature of the mutual responsibilities between ABCORI and its covenanting churches is set forth in the document "The American Baptist Churches of Rhode Island, A Covenant of Relationships."
- 3. An associating congregation may be dually aligned with another Christian denomination or Baptist convention.

SECTION B. CHURCH DELEGATES

Each constituent member church shall be entitled to representation at the Annual or Special Meetings of the American Baptist Churches of Rhode Island by its pastor(s) and two (2) delegates for the first fifty (50) resident members (as reported annually to the office of the American Baptist Churches of Rhode Island), plus one delegate for each additional fifty (50) members, or the major portion thereof. Each pastor and delegate shall be entitled to one vote. Delegates shall be appointed by the member church.

ARTICLE V - ANNUAL AND SPECIAL MEETINGS

SECTION A. ANNUAL MEETING

The Annual Meeting of the American Baptist Churches of Rhode Island shall include but not be limited to: establishing ministry priorities; acting on the report of the Recruitment Committee; receiving and acting on a report of the financial status; and any other appropriate business to come before the delegates.

- 1. The Annual Meeting of the American Baptist Churches of Rhode Island shall be held between March 1 and May 31 of each year at such date as shall be determined by the Board of Ministries. The date and location of the Annual Meeting shall be determined by the Board of Ministries at least one year in advance.
- 2. A quorum for transaction of business shall consist of one or more delegates representing at least one-third (1/3) of constituent members. Less than this number may adjourn a meeting and a notice of such adjournment shall be sent in the same manner as notice of meetings.
- 3. The Annual Meeting may be recessed or rescheduled by the Board of Ministries in case of emergency. The Board of Ministries shall have authority to transact business until such time as it is possible to call an Annual Meeting which it must do within 60 days.

SECTION B. SPECIAL MEETINGS

- 1. A special meeting of American Baptist Churches of Rhode Island shall be called by the President whenever requested by the Board of Ministries or by the written request of ten (10) constituent member churches. The call shall state the time, place and purpose of the meeting.
- 2. A quorum shall be the same as required for an Annual Meeting.

SECTION C. NOTICE OF MEETINGS

Notice of annual or special meetings of ABCORI shall be sent by mail by the Secretary to each constituent member church at least two weeks prior to the day of the meeting.

ARTICLE VI - OFFICERS, THEIR ELECTION AND DUTIES

SECTION A. ENUMERATION

The officers of the American Baptist Churches of Rhode Island shall be a President, Vice President, Secretary (who shall be the Executive Minister), Clerk, and Treasurer. All officers shall be members in good standing of an ABCORI church.

SECTION B. ELECTION AND TERM OF OFFICE

- 1. Other than the Secretary, the officers shall be elected at the Annual Meeting of the American Baptist Churches of Rhode Island, take office at the end of the adjournment of the meeting at which they are installed and shall serve their complete term(s) or until their successors are installed.
- 2. A vacancy in any office shall be filled by election by the Board of Ministries for the unexpired term of such office upon recommendation of the Recruitment Committee unless stated elsewhere in these By-laws.
- 3. The President and Vice President shall be eligible to serve for one two year term. No person shall be eligible for reelection to the same office until three years have elapsed from the completion of a prior term in that office.
- **4.** The Clerk and Treasurer shall each be eligible to serve for a maximum of three consecutive two year terms in the same office, and shall not be eligible for re-election to the same office until three years have elapsed from the completion of a prior term in that office.

SECTION C. PRESIDENT

The President shall preside at all meetings of the American Baptist Churches of Rhode Island and the Board of Ministries and shall be a member ex-officio of all Ministry Teams, the Operations Team, and all Committees. The President or Treasurer, when authorized by the Board of Ministries, shall execute on behalf of the American Baptist Churches of Rhode Island all deeds, mortgages, transfers and discharges of mortgages and assign all securities for transfer or sale. The President shall perform such other duties as are set forth elsewhere in these By-laws, including appointing:

- 1. The Chair and at large members of an Executive Staff Search Committee
- 2. The Chair of the Standing Committee on Ordained Ministry
- 3. The Chair of the Operations Team
- 4. Committees and task forces to carry out the work of the Board of Ministries
- 5. The By-law and Constitution Review Committee (every five years)

SECTION D. VICE PRESIDENT

In the absence or disability of the President, the Vice President shall perform the duties of the President. If a President is not able to complete his/her term, the Vice President shall become President until the next Annual Meeting Installation. The Vice President shall then be eligible to serve another full term as President. A Vice President shall then be elected by the Board of Ministries according to the process in Article VI, Section B2. This person shall serve until the next Annual Meeting Installation, and be eligible for another full term. The Vice President shall be a member ex-officio of the Operations Team.

SECTION E. SECRETARY

The Executive Minister shall serve as the Secretary of the corporation, as indicated in the covenant of relationships with ABC-USA. This is a non-voting position on the Board of Ministries. The Secretary in cooperation with the clerk shall maintain copies of all ABCORI policies.

SECTION F. CLERK

The Clerk shall be responsible for recording minutes of all ABCORI meetings and preserving them at the offices of ABCORI. The Clerk shall send copies of the minutes to the Baptist Heritage Center and any other affiliated organizations that request them. The Clerk shall also maintain copies of all ABCORI policies in cooperation with the Secretary. In the event the Clerk is unable to complete his/her term, an elected person shall be considered to have served a full term if serving more than half of the unexpired term.

SECTION G. TREASURER

The Treasurer shall have responsibility for all monies, books and accounts, securities, contracts, and financial papers of the American Baptist Churches of Rhode Island. Policies regarding finances and the reporting of finances shall be established by the Board of Ministries and made public. The Treasurer or President, when authorized by the Board of Ministries, shall execute on behalf of the American Baptist Churches of Rhode Island all deeds, mortgages, transfers and discharges of mortgages and assign all securities for transfer or sale. In the event the Treasurer is unable to complete his/her term, an elected person shall be considered to have served a full term if serving more than half of the unexpired term.

- 1. The Treasurer shall be a member of the Operations Team and the Baptist Fund of Rhode Island.
- 2. The Treasurer shall be bonded for the faithful discharge of duties in such sum and with such sureties as the Board of Ministries may require and approve.

ARTICLE VII - STAFF

SECTION A. EXECUTIVE STAFF

The executive staff shall be the Executive Minister and such others as from time to time shall be deemed necessary by the Board of Ministries for the accomplishment of ABCORI's mission. Executive staff shall be American Baptists.

EMPLOYMENT

- a) To fill the position of Executive Minister, a Search Task Force shall consist of: 3 members elected by the Board of Ministries, a member of the Rhode Island Ministers Council, a member of the Personnel Committee, one representative from American Baptist Women's Ministries of Rhode Island, a young adult (age 18-35); and two to four at-large members appointed by the President. Every effort shall be made to form a task force that is as inclusive and diverse as possible.
- **b**) Ex-officio members (without vote) of the Executive Minister's Search Task Force will be a representative of the General Secretary of ABC-USA and the President of ABCORI.
- c) To fill other executive staff positions, a search task force representing the Board of Ministries and the Personnel Committee shall be appointed by the President to work with the Executive Minister. All executive staff shall be offered employment and employment terms with vote of the Board of Ministries.

SECTION B. OTHER STAFF MEMBERS

The Executive Minister shall be responsible for the employment of all other staff members following written Personnel Policies. The Executive Minister may delegate hiring and supervisory responsibilities to other staff as appropriate.

SECTION C: TERMINATION OF STAFF

All issues related to resignation, retirement, dismissal, and disability will follow written Personnel Policies.

ARTICLE VIII - BOARD OF MINISTRIES

The Board of Ministries shall be the governing board of the American Baptist Churches of Rhode Island, and shall have responsibility for all ABCORI assets. The Board of Ministries shall establish all policies for American Baptist Churches of Rhode Island. The Clerk and the Secretary shall maintain copies of these policies. All voting members of the Board of Ministries have voting privileges at all ABCORI business meetings. All members of the Board of Ministries shall be members in good standing of an ABCORI church.

SECTION A. COMPOSITION

The Board of Ministries shall consist of: The Officers and (non-voting) executive staff of the American Baptist Churches of Rhode Island; ABC-USA General Board Representative(s); the chair of the Operations Team; one representative from each ministry team; the immediate past president of ABCORI; the chair or a representative of the Standing Committee on Ordained Ministry; three (3) at-large members; a representative of American Baptist Women's Ministries of Rhode Island; and a representative of the Baptist Home of Rhode Island (without vote).

SECTION B. TENURE - Tenure for members of the Board of Ministries shall be as follows:

- 1. Representatives of affiliated organizations and ministry teams shall be members for as long as they hold office.
- 2. At-large members shall be elected for a three-year term and in such manner that one third (1/3) of the terms shall expire annually. At-large members shall be eligible for one (1) additional full three-year term.
- 3. Vacancies shall be filled by the Board of Ministries after receiving nominations from the Recruitment Committee.

SECTION C. DUTIES OF THE BOARD OF MINISTRIES

The Board of Ministries shall be responsible to:

- 1. Establish policy for ABCORI;
- 2. Establish, implement, and evaluate ABCORI priorities and objectives;
- 3. Approve an ABCORI budget to recommend for adoption at the ABCORI Annual Meeting;
- 4. Confirm all Presidential appointments;
- 5. Evaluate the Executive Minister according to the Personnel Policies;
- 6. Establish any Task Force or Committee necessary for the functioning of the Board of Ministries;
- 7. Exercise all powers of the American Baptist Churches of Rhode Island between Annual Meetings.

SECTION D. MEETINGS OF THE BOARD OF MINISTRIES

- 1. There shall be at least six (6) meetings held during the year as scheduled by the Board.
- 2. Special meetings may be called by the President or by the Executive Minister upon receipt of written request of one-third plus one members of the Board of Ministries.
- 3. Each member of the Board of Ministries shall be notified at least two weeks prior to the day of the meeting.
- 4. Quorum shall consist of 50% plus one of the voting members of the Board of Ministries.
- 5. At the discretion of the President, an Executive Session of the Board of Ministries may be held during any regularly scheduled Board of Ministries meeting.
- 6. In the intervals between meetings, the Board of Ministries may conduct business by conference call or electronic vote, following the meeting procedures above.

SECTION E. EXECUTIVE COMMITTEE OF THE BOARD OF MINISTRIES

- 1. There shall be an Executive Committee of the Board of Ministries which shall act as a leadership team of the Board to assist the President and Executive Minister in planning and prioritizing board activities between meetings of the same. The Executive Committee shall meet on the call of the President or the Executive Minister, or when requested by two or more members thereof.
- **2.** The Executive Committee of the Board of Ministries shall be composed of the President, Vice President, Clerk, Treasurer, Executive Minister, and the Chair of the Operations Team.

ARTICLE IX: COMMITTEES

There shall be committees and task forces formed to carry out the work of the Board of Ministries. Members of ad hoc committees and task forces shall either be appointed by the President with approval of the Board of Ministries, or hold membership by virtue of their position. The President shall designate the Chairperson of each committee from the membership of the committee subject to the approval of the Board of Ministries. All committee members shall be members in good standing of an ABCORI church. Committee members may serve two full three-year terms in any position.

SECTION A. RECRUITMENT COMMITTEE

- 1. The Recruitment Committee shall be composed of the immediate past president of ABCORI who will serve as Chairperson; the President or a designee of the American Baptist Women's Ministries, the President of the Rhode Island Ministers Council; the chair of the Operations Team or a designee, and three members-at-large, who shall serve for three (3) year terms.
- 2. The Committee shall serve as the nominating committee for officers of the American Baptist Churches of Rhode Island, its Board of Ministries, Operations Team, Personnel Committee, Investment Committee, Properties Committee, Recruitment Committee, Ministry Teams, members of the Executive Minister's Relations Committee, and

- all delegates to other recognized groups. All nominations shall be confirmed by vote of the Annual Meeting or the Board of Ministries.
- 3. The Committee shall make recommendations to the President for all positions filled by presidential appointment.
- 4. This Committee, in presenting nominations, shall give consideration to adequately represent its diverse constituency.

SECTION B. EXECUTIVE MINISTER'S RELATIONS COMMITTEE

This Committee of five (5) persons shall consist of three members nominated by the Executive Minister and two members nominated by the Recruitment Committee. These members shall all serve a maximum of two (2), three-year (3) terms on a rotating basis. This committee shall foster constructive communication between the ABCORI constituency and the Executive Minister and shall encourage the professional and personal well-being of the Executive Minister.

SECTION C. STANDING COMMITTEE ON ORDAINED MINISTRY

- 1. The Standing Committee on Ordained Ministry shall be responsible for all aspects of ordering Pastoral Ministry within the American Baptist Churches of Rhode Island. It shall create and publish policies and procedures pertaining to all issues of Ordained Ministry, which shall be ratified by the Board of Ministries.
- 2. Composition: Three lay persons and three pastors shall be appointed for a three year term, each in such a manner that the term of one layperson and one pastor will expire annually. Five (5) officers of the Rhode Island Ministers Council shall serve on the committee by reason of their office. A representative of Rhode Island Baptist Education Society (RIBES) shall also serve on the committee. The Executive Minister shall be ex officio with vote. Appointed members shall be eligible for one additional three-year term and be eligible for a new appointment after the lapse of one year.
- 3. The chairperson shall be appointed annually by the President from among the ordained members of the committee.
- 4. The chairperson or a designee shall be a voting member of the Board of Ministries.

SECTION D. TASK FORCES OF THE BOARD OF MINISTRIES

- 1. Task forces may be formed by the Board of Ministries for programmatic or task work of the board upon the presentation of a proposal and/or budget request. Membership of a task force shall be recruited from constituent member churches and a Chairperson designated.
- 2. A task force may function for up to three years and shall be evaluated periodically.
- 3. Funding for all task forces will be through the approved budget process.

ARTICLE X- OPERATIONS TEAM

The Operations Team shall have the responsibility for administering the stewardship, personnel, financial, and business affairs of the corporation. All Operations Team members shall be members in good standing of an ABCORI church.

SECTION A: RESPONSIBILITIES

The Operations Team shall be responsible for the following:

- 1. Reviewing and monitoring the annual budget for American Baptist Churches of Rhode Island.
- 2. Overseeing all investments.
- 3. Having responsibility for all fund raising and development activities within ABCORI.
- 4. Administering all designated funds.
- 5. Being custodian of all properties of the corporation.
- 6. Manage human resources of the organization.
- 7. Overseeing the following committees: Personnel, Budget, Baptist Fund of RI, Properties, and Investments.
- 8. Convening other committees and task forces as needed.
- 9. Periodic review of all operational policies and procedures of the organization.

SECTION B: COMPOSITION

The Operations Team shall be led by a Chair who is appointed by the President for a two-year term. The following positions shall be elected for three year terms: development, fundraising, and grant writing. In addition the following shall serve by virtue of their positions: ABCORI Treasurer, such staff as are responsible for ABCORI operations, and chairs of Operations committees who shall be appointed annually by the chair of Operations from among the elected members. Elected members may serve two consecutive full terms. Members of committees of the Operations Team shall be nominated by the Recruitment Committee in consultation with the individual committees.

SECTION C: MEETINGS

The Operations Team shall meet at least six times each year.

SECTION D: PERSONNEL COMMITTEE

- 1. The Personnel Committee shall consist of five (5) persons to be divided into three classes (2, 1, and 2), for a term of three years. Members shall be eligible for one additional three-year term and be eligible for a new appointment after the lapse of one year.
- 2. This Committee shall develop and publish personnel policies and provide for regular evaluation of all staff.
- 3. This committee shall serve as a forum for grievances or concerns among staff which any staff member feels is not being addressed by the organization and/or its staff.
- 4. This Committee shall consult with the Executive Minister regarding salaries, wages, and benefits for each staff member. The Committee will make recommendations to the Budget Committee.
- 5. This committee shall participate on search task forces for executive staff as outlined in Article VII, A3.

SECTION E: BUDGET COMMITTEE

The Budget Committee shall consist of a Chair, the Operations Chair, the Treasurer, the Executive Minister, and ABCORI staff and committee chairs as invited by the Budget Committee Chair. The Budget Committee shall prepare the annual budget. On a quarterly basis, the Committee shall review and compare actual financial performance to budget and make recommendations to the Operations Team.

SECTION F: BAPTIST FUND OF RHODE ISLAND

The Baptist Fund of Rhode Island (BFRI) exists to serve ABCORI churches, and also helps ABCORI pastors and spouses who find themselves in a financial crisis when all other sources of money have been explored. The Fund makes grants to Partners in Ministry in the community. The three sources of income to support this ministry are endowment income designated for BFRI, repayment of loans, and annual contributions from ABCORI churches through line items in their budgets. BFRI consists of the ABCORI President, ABCORI Treasurer, Chairpersons of the Operations Team and the Rhode Island Ministers Council, the Executive Minister, Bookkeeper, and three members at large.

SECTION G: INVESTMENT COMMITTEE

The ABCORI Investment Committee is charged with overseeing the management of the ABCORI Pooled Investment Fund. The committee is responsible for selecting the Fund Manager and accounting firm to process the activity of the Investment Fund providing reports to each fund participant. This committee is responsible for working with the Fund Manager to determine the investment strategy for the fund and the rate of return paid quarterly to the participants. The committee reports regularly to the Operations Team, and annually to the Board of Ministries. Membership of this committee shall consist of three (3) at-large members, the Treasurer and the Chair of the Operations Team.

SECTION H: PROPERTIES COMMITTEE

The Properties Committee shall work with the ABCORI administration to ensure both long and short range quality care of the properties of ABCORI. The Committee shall provide guidance regarding the prioritization of work on the properties and capital expenditures, as well as the annual properties budget. Membership of this committee shall consist of six (6) at-large members.

ARTICLE XI: AREAS OF MINISTRY TEAMS

The Areas of Ministry Teams shall have the responsibility for planning and implementing programs in the ABCORI areas of ministry.

SECTION A: COMPOSITION

Each Ministry Team shall consist of a minimum of five (5) members, who shall be elected on a rotating basis for three year terms. Each member may serve two full terms on a team and may return to serve two more terms after a one-year absence. All members must be members in good standing of an ABCORI Church. The members of the team may choose to distribute responsibility for some of the functions in order to guarantee continuity. Staff with responsibilities related to the ministry teams may serve as ex-officio members. The Executive Minister shall assist in coordinating the work of the Ministry Teams.

SECTION B: MEETINGS

The individual Ministry Teams shall meet as needed to complete their work.

COORDINATING MEETINGS

- 1. The Executive Minister will convene a Coordinating Meeting quarterly
- 2. At least one member of each Ministry Team shall attend the Coordinating Meeting.
- 3. The agenda for each meeting will be to coordinate programs, spiritual life, and communications.

SECTION C: RESPONSIBILITIES

The Ministry Teams will:

- 1. Elect a convener and a representative to the Board of Ministries from among the members of the teams.
- 2. Establish annual goals
- 3. Meet at least six (6) times a year and establish the agenda for each meeting, based on appropriate functions, and specific and appropriate requests from churches.
- 4. Issue individual and public invitations to people interested in the topic to be addressed.
- 5. Keep records of all projects underway.
- 6. Assist persons who undertake particular responsibilities such as making phone calls or writing emails or letters, making visits or organizing side meetings, or overseeing production of promotional materials.
- 7. Oversee the progress of particular projects.
- 8. Send a representative to the Coordinating Meetings.

SECTION D: PASTORAL LEADERSHIP MINISTRIES TEAM

The Rhode Island Ministers Council will be invited to participate in all dialog meetings related to the functions of this area of ministry in order to insure the continuation of a collegial relationship between ABCORI and the Ministers Council. The Pastoral Leadership Team shall:

- 1. Collaborate with SCOM on issues relating to ordained ministry.
- 2. Oversee the interim ministers' network.
- 3. Support new pastors, church planters and covenant pastors.
- 4. Address pastoral development issues.
- 5. Address pastoral support matters.

SECTION E: CONGREGATIONAL LIFE MINISTRIES TEAM

- 1. Oversee public relations and special events including the Annual Gathering.
- 2. Oversee new church planting, envisioning, pastoral searches, and church renewal.
- 3. Oversee church administration and resourcing issues.
- **4.** Facilitate conflict management within local congregations.

SECTION F: SOCIAL WITNESS MINISTRIES TEAM

- 1. Oversee interfaith and ecumenical work.
- 2. Oversee peace, environmental and social justice issues.
- 3. Consult with the Ministry of Eldercare on chaplaincy and eldercare issues.
- 4. Oversee local mission efforts.

SECTION G: EVANGELISTIC WITNESS MINISTRIES TEAM

- 1. Oversee evangelism training.
- 2. Oversee evangelism efforts.
- 3. Promote American Baptist local, national, and international mission.
- 4. Oversee mission explosions.
- 5. Oversee mission trips and missionary speakers.

SECTION H: CAMPING AND YOUTH MINISTRIES TEAM

This team collaborates and advises a variety of special groups, including, but not limited to, the ABCORI Youth Ministry Planning Team (YMPT) and the Program Advisory Team (PAT) to accomplish the following:

- 1. Advise and collaborate with staff regarding camp curriculum and programming.
- 2. Focus on youth ministry, discipleship, inter-generational ministry and Christian Education.
- 3. Focus on spiritual growth and development within local churches, groups, and communities.
- 4. Promote youth, camping, and other specialized ministry within ABCORI, local churches and communities.

ARTICLE XII – AFFILIATED ORGANIZATIONS

SECTION A. DEFINITION

Affiliated Organizations are those whose constitution and by-laws have been approved by the delegates of ABCORI.

SECTION B. ENUMERATION - The following are recognized as affiliated organizations:

American Baptist Women's Ministries of RI (ABWMRI)

Baptist Heritage Center (BHC) Baptist Home of RI (BHRI) Rhode Island Ministers Council RI Baptist Education Society (RIBES)

SECTION C. RELATIONSHIP TO ABCORI

- 1. American Baptist Women's Ministries of RI has representation with vote on the Board of Ministries. Baptist Home of RI has representation on the Board of Ministries without vote.
- 2. Affiliated organizations will submit an annual report, including financial statement(s) and a list of officers and board members for publication in the ABCORI Directory and Yearbook.
- 3. In all matters not specified in this Constitution, affiliated organizations are autonomous, nor does ABCORI have any administrative, fiscal, legal or other responsibility for any affiliated organization.

ARTICLE XIII - AMENDMENTS

This Constitution and By-laws may be amended or revised by a vote of two-thirds (2/3) of the delegates present and voting at an Annual Meeting or a special meeting of the delegates as defined under Article V. Written notice of all amendments and/or revisions shall be mailed to all constituent churches and delegates at least two weeks prior to the date of the meeting.

ARTICLE XIV- BY-LAW AND CONSITUTION REVIEW

This Constitution and By-laws shall be reviewed every five (5) years by a committee appointed by the President.

ARTICLE XV - INDEMNITY

The power of indemnification under the laws of Rhode Island shall not be denied or limited by the By-laws.

ARTICLE XVI - PARLIAMENTARY AUTHORITY

The rules contained in <u>Robert's Rules of Order, the Modern Edition</u> shall govern the American Baptist Churches of Rhode Island in all cases in which they are not inconsistent with the Constitution and By-laws and special rules of the corporation. The President should appoint a parliamentarian for annual and special meetings.
